

General Terms and Conditions for Swiss Snowboard Speed Tour 2024/25

- ▷ The organizer of the events is the respective Organizing Committee (OC).
- ▷ The online registration deadline is indicated in the event information, available for download in the online registration tool.
- ▷ The number of available slots is limited, and registrations will be considered in the order they are received.
- ▷ Registrations are fundamentally accepted only online.
- ▷ Late registrations are allowed only if circumstances permit; the decision lies with the jury (Late registration fee: CHF 30.- per athlete).
- ▷ Lift tickets can be refunded in the event of competition cancellation or non-usage until a specified deadline. Discounted tickets must not, under any circumstances, be transferred or resold to third parties.
- ▷ Prepaid online registration and ticket fees will be refunded in cases of illness or injury upon presentation of a medical certificate.
- ▷ Payment system: Registration and ticket fees can be settled using Visa card, Mastercard, PostFinance, or American Express during online registration. The payment system is operated by FEM-Service.
- ▷ In case of cancellation, the already paid registration fees will be refunded as follows:
 - Cancellation >48h* before the competition: 100% refund of the registration fee.
 - Cancellation >24h* before the competition: 50% refund of the registration fee.
 - Cancellation <24h* before the competition: No refund of the registration fee.
 - *Definition of time: 9:00 am before the competition day.
- ▷ Participants are responsible for their insurance. The organizer disclaims any liability for accidents, damages, and theft. Wearing a helmet is mandatory.
- ▷ Wearing protectors (back protection) is recommended.
- ▷ Participants' equipment must be functional and properly adjusted.
- ▷ Minors may only be registered with the consent of their legal guardians.
- ▷ By registering, participants automatically agree to abide by the applicable competition rules, the FIS ICR, additional rulebooks, and the privacy policy.
- ▷ The precise schedule of the contest will be published during the Team Captains' Meeting.
- ▷ The lists of participants, start lists, and rankings will be publicly available on the Swiss-Ski and FEM-Service websites for each event.
- ▷ SMS and email service: Telephone numbers and email addresses will be used for potential communications in case of urgent information (e.g., event cancellation in the morning, updates on weather conditions, etc.).
- ▷ Protecting personal data is important to us. Our privacy policy explains the handling of personal information.
- ▷ Participants consent to the use and processing of photos and videos for illustrative purposes on websites, publications, and marketing materials directly associated with the Swiss Snowboard Speed Tour (e.g., promo booklets, advertisements, reports in newspapers or magazines, YouTube, and website content) by Swiss-Ski, sponsors, and partners.
